Our Commitment to Privacy

Your privacy is important to us. To better protect your privacy we provide this notice explaining our online information practices and the choices you can make about the way your information is collected and used.

The Information We Collect:

This notice applies to all information collected or submitted on the Bozeman Blitzz website (www.bozemansoccer.org or www.gotsport.org). On some pages, you can order soccer services. The types of personal information collected at these pages are:

The Way We Use Information:

We use the information you provide about yourself when placing an order only to complete that order. We only share this information with affiliates of US Youth Soccer as required by charter.

We use return email addresses to answer the email we receive. Such addresses are not used for any other purpose.

Finally, we never use or share the personally identifiable information provided to us online in ways unrelated to the ones described above without also providing you an opportunity to opt-out or otherwise prohibit such unrelated uses.

Our Commitment to Data Security

To prevent unauthorized access, maintain data accuracy, and ensure the correct use of information, we have put in place appropriate physical, electronic, and managerial procedures to safeguard and secure the information we collect online.

How You Can Access or Correct Your Information

You can access all your personally identifiable information that we collect online and maintain by contacting the Bozeman Blitzz at 406-600-8146 or by submitting a written request to the Bozeman Blitzz FC, P.O. Box 4349, Bozeman, MT 59772 or lastly by using the online account provided during registration. We use this procedure to better safeguard your information.

To protect your privacy and security, we will also take reasonable steps to verify your identity before granting access or making corrections.

Refund Policy

- Voluntary withdrawal before tryouts will result in an automatic refund of all but \$50 (club cost for insurance and administration).
- Voluntary withdrawal after tryouts will **not** result in a refund.
- If we cannot place your player on a team we will refund all but \$25 (state registration and insurance fee).
- Involuntary withdrawal (catastrophic injury, family relocation...) may result in a refund of up to half of the tuition paid, but must be requested in writing, through the Club Administrator, after January 1 and before May 1.
- Lack of understanding of Club policies and procedures is **not** grounds for involuntary withdrawal.
